e) Sirens – All sirens are back to normal function. Sirens are not currently on insurance. 2012 they were updated and are set off by radio frequency, not phone lines. MOU; owned by City; maintained by City; if malfunction is due to radio frequency then county is responsible. Waiting on city approval to agreement.
